

**INNO-DEZ**  
Disinfectant for treating surfaces

**Microbial spectrum:** bactericide (MRSA), fungicide, virucide, micobactericide.

**Conditions of application -**

concentration	working time	effect
2%	15 min.	bactericide, fungicide
2%	20 min.	micobactericide
4%	60 min.	virucide

**Areas and methods of usage:** the preparation can be applied in various fields of private and public health care, food industry and catering where cleaning and disinfection of surfaces is required. Prepare a work solution of the preferred concentration and temperature (20-60°C) and perform the operation with this solution. It can be put onto the affected surface by spraying, brushing, immersing or other ways. Cleaning can be made more efficacious by mechanical means. Finally, remove the remains of the preparation by rinsing the surface with water (one with drinking-water quality in case of surfaces contacting with foodstuffs). The cleaning and disinfecting procedure should always be carried out with a newly-made work solution. Do not mix the preparation with any other cleaner or disinfectant.

**Flammability:** not flammable

**Safety recommendations:** use the fluid preparation exclusively for its function in accordance with general labour hygienic and labour safety instructions.

P304 + P340 - If inhaled: Remove person to fresh air and keep comfortable for breathing.

P305 + P351 + P338 - If in eyes: Rinse cautiously with water for several minutes.

Remove contact lenses if present and easy to do. Continue rinsing.

P391 - Collect spillage.

P405 - Store locked up.

**Environmental protection:** the contaminated solution can be discharged into public drains after being processed and neutralised appropriately, depending on contaminations, in accordance with general and local regulations. 20-litre cleaned containers can be handled as municipal waste.

P501 - Dispose of contents/container in accordance with local regulations.

P273 - Avoid release to the environment.

**Storage:** store the preparation in its original unopened container at a dry cool place in accordance with general instructions of storing chemicals.

P102 - Keep out of reach of children.

**Quality preservation time:** 36 months after the production date in case of appropriate storage conditions (1 year if unwrapped).

**Packaging units:** 20l and 5l can, 1l flacon.
