

## *INNO-SEPT Disinfecting Solution*

**Microbial spectrum:** bactericide (MRSA), fungicide, yeasticide, selective virucide (also against enveloped viruses and avian influenza), mycobactericide.

**Conditions of application:** concentrated state; working time: 2 min.; for the fungicidal effect: 15 min.

**Areas and methods of usage:** the product is designed for professional use. It can be applied in various fields of private and public health care, catering and other services. It is suitable for disinfecting objects, worktables and other surfaces. Spray the affected surface evenly with the preparation; after the working time, it will be hygienically correct. For stronger contaminations, we recommend the preliminary usage of a more intensive cleaner (Innofluid-Alk-M).



**EU hazard symbol:**

**Flammability:** category II

**Safety recommendations:** use the preparation exclusively for its function in the appropriate way according to general labour hygienic and labour safety instructions.

H319 - Causes serious eye irritation.

H226 - Flammable liquid and vapour.

P210 - Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking.

P233 - Keep container tightly closed.

P280 - Wear protective gloves / protective clothing / eye protection / face protection.

P304 + P340 - If inhaled, remove person to fresh air and keep comfortable for breathing.

P305 + P351 + P338 - If in eyes, rinse cautiously with water for several minutes.

Remove contact lenses if present and easy to do. Continue rinsing.

P337 + P313 - If eye irritation persists, get medical advice/attention.

P370+P378 - In case of fire, use powder, carbon dioxide, water spray or alcohol-resistant foam to extinguish.

In case of ingestion, remove the victim to fresh air, give her/him plenty of water to drink and call a physician to the premises immediately. Never induce vomiting!

**Environmental protection:** do not discharge the disinfecting solution or its packaging to the environment. The preparation easily degrades biologically; adverse environmental effects are not expectable. Handle the generated sewage depending on contaminations, complying with local regulations. Cleaned containers can be handled as municipal waste as long as their volume does not exceed 20l.

P501 - Dispose of contents/container in accordance with local regulations.

**Storage:** store the preparation in its original package at a dry cool but freeze-free place protected from sunlight, separated from foodstuffs and sources of heat or ignition.

P102 - Keep out of reach of children.

P403 + P235 - Store in a well-ventilated place. Keep cool.

**Packaging units:** 20l and 5l can, 1l flacon with a sprinkler head.
